Day 1: Keynote Speakers

Jasmina Bajraktarevic-Hayward

Jasmina Bajraktarevic-Hayward is a Social Worker (Hon 1, University Medal) and the Community Services Coordinator at STARTTS. Her involvement in the refugee field dates back to 1991, when she became involved in work with Bosnian refugees in Croatia through a local implementing partner of the UNHCR. Jasmina's knowledge and expertise ranges from individual trauma counselling, through to group work and community development, to management and staff supervision. She is a highly experienced presenter and trainer on refugee issues, particularly in the field of community development.




Dr Munjed al Muderis

Dr Al Muderis is an Australian trained Orthopaedic Surgeon and a Squadron Leader in the Australian Air Force Reserve. He is also an Ambassador for the Australian Red Cross, a human rights activist and a refugee. He teaches at Notre Dame and Macquarie Universities, trains local and international surgeons, and registrars.

Apart from his academic and clinical roles, Munjed is heavily involved in humanitarian work volunteering his time as a surgeon and as a human rights advocate. He has affiliations with Amnesty International and United Nations High Commissioner for Refugees (UNHCR).

Jim Ife

Jim Ife is a Profesor of Social Work at Western Sydney University. He has written extensively on community development, human rights and social work, and his book 'Community Development in an Uncertain World' has been used extensively as a text-book. He is a former President of Amnesty International Australia, and former convenor of the Human Rights Commission of the International Federation of Social Workers. He has a long-standing commitment to community development based on cultural diversity and decolonising practice.

Paul Power

Paul Power is the Cheif Executive Officer of the Refugee Council of Australia (RCOA), the national peak body for 200 agencies working with refugees and asylum seekers. Since 2006, Paul has led the organisation's policy development and public education on refugee issues and its advocacy with the Australian Government, and the Office of the United Nations High Commissioner for Refugees. Prior to joining RCOA, Paul worked in the NGO sector as a media officer, trainer, researcher and manager. Through his NGO work, Paul has been involved with projects in international aid, community development, mental health support, volunteer training, social research and advocacy.

Dr Asha Chand

Dr Asha Chand is Associate Dean International for South Asia in the School of Humanities and Communication Arts at Western Sydney University. She is also a senior lecturer and journalism area convenor. Asha migrated to Australia in 1998 from Fiji under conditions of crisis. Asha believes in the power of story-telling and the hope journalism lends to voiceless people, especially migrants and refugees. She endeavours to help inspire more people to tell their stories so that they can build capacity for change and improvement in attitudes and views on refugees and migrants.

Roza Germian

Roza was born in the second year of the eight year-long Iran-Iraq war, in 1981, in the city of Kirkuk north of Iraq which had a Kurdish majority. Eventually, her family along with four million Kurdish people became refugees in Iran and Turkey. Her family then spent two years in Turkey as refugees before reaching the safety of Australia in 1996.

After learning English, she started High School from grade 10, and then went on to study a Bachelor of Communication-Journalism, at UWS and graduated in 2004. In 2006 Roza completed a double Masters degrees in International Relations and International Communication Macquarie University. Roza started working at SBS Radio in 2013, as a producer for the Kurdish Program, and is now the Executive Producer there.

Philippa McDonald
Philippa McDonald is a senior reporter at the

Australian Broadcasting Corporation. She has been responsible for reporting many of the biggest news stories in Australia and overseas for ABC News for the past 27 years. Philippa has covered politics, elections, terrorism, earthquakes, coups, human rights, aviation disasters, a lot of crime, an array of important social issues and the arts. Her work has taken her all over Australia, New Zealand, Fiji, the Solomon Islands, Indonesia, China, Thailand, Myanmar, Cambodia, the Philippines, South Korea, Britain and India. Most recently Philippa has been the face of the ABC's coverage of the Royal Commission into Child Sexual Abuse. Philippa is also the recipient of a United Nations Association Media Peace Prize for her and her team's

investigation into the plight of Myanmar's

refugees.

During Sudan's war of 1983-2005, Atem took part in peace talks to end the armed conflict between the insurgents and the Government of Sudan. Following this role, he served as a counterpart relief worker for the United Nations humanitarian programme, Operation Lifeline Sudan.

In 2000, Atem became a permanent resident of Australia. At the end of 2009, he returned to Sudan to participate in the independence referendum. Since then, Atem has trained as a journalist in Sudan, Germany and the UK (master's degree from the University of Wales, UK). He also has worked as an editor of several newspapers and magazines in both Sudan and Kenya.

My name is Alice Clarke and I am an aged care nurse in the community and I have four children. I arrived in Australia in August 2002 from West Africa because I had to leave my home in Liberia because of the civil war. I became very involved in my community and am currently the Chairlady of the African Women of Faith Organisation which was started in February 2008.



Om Dhungel

Om Dhungel is a consultant, trainer and a mentor and a practitioner of Strength-Based Approach to refugee settlement and community engagement. He is currently a Director on the Board of the Asylum Seeker Centre. He has served on the Boards of Settlement Services International, SydWest Multicultural Services and MTC Australia in the recent past. Om is the founding President and currently a senior member of the Association of Bhutanese in Australia (ABA) Sydney.

Mohammed Dukuly

My name is Mohamed Salia Dukuly. National Leader of the Liberian community in Australia, a small and emerging African community in Australia. We are spread around the different states and mostly concentrated within the Western Sydney areas of Sydney. The community is very diverse on many levels. Religiously, there are approximately about 92% Christians and 5% Muslims and 2% other faiths. Most of the community subgroups are tribal or region based.





Ernie Friedlander

I was born in Vienna, Austria. I am a Holocaust survivor, alive probably due to the humanity of a German soldier, who gave my mother and me the opportunity to sneak away. I am a member of the B'nai B'rith Alfred Dreyfus Anti Defamation Unit, a Worldwide Jewish service organisation, which instigated the Moving Forward Together Association, of which I am the President. I arrived in Australia in December 1950.



Lydia Gitau

Lydia Gitau is a graduate of the Centre for
Peace and Conflict Studies, University of
Sydney. She is currently working as a Training
Officer at STARTTS and as a part-time
lecturer. Lydia is passionate about examining
the post-conflict interventions that have the
potential to support long-lasting peace for
survivors of conflict and mass violence.

Sofia Ihsan

My name is Sofia Ihsan. I am 18 years old. I am studying Bachelor of Social Science at Macquarie University. I belong to the Ahmadiyya Muslim Community. My community is widely persecuted in countries like Pakistan, Bangladesh, Malaysia and the Middle East due to a slight difference of beliefs of my community with other Muslims. Due to this persecution my mother sought refuge in Australia in 2010. My father and I came 2 years after her. Since then my family has been leading a safe and happy life here in Australia. I have always had the passion to work in the welfare sector and make a positive difference in the society.



Emmanuel Kondok

My name is Emmanuel Kondok and I was born in South Sudan. I was forced to leave Ethiopia and I arrived in Kenya in 1992. I was one of the founders of the Kakuma Refugee Camp. In 2005 I was granted permanent residency and I came to Australia with my family and NSW became my home. Ever since, I have been consistently working in different community development roles and am currently the Chair of the Community of South Sudanese and Other Marginalised Areas in NSW (CSSOMA).





Natalie Martlignago

Natalie Martignago is a community organiser with Sydney Alliance; a coalition of faith groups, unions and community organisations.

Born and raised in South-West Sydney, Natalie learnt of the legacy of hard work from her migrant parents and grandparents. Now, she is working to ensure that Australia is built by and for all its people, not just a few.

Jude Simion

I have been in Australia for the last ten years and am working for a faith based community organisation called PHILOI as the Chief Operating Officer. I have been involved in organizations based or working in over 25 countries including Syria, Iraq and South Sudan. I currently serve as the Global Facilitator of the Refugee Highway Partnership, an international network of churches, agencies and individuals serving forcibly displaced people.

RAHATT: Assyrian Women's Choir







Fahema, Seham and Hayat are three women who are members of Reconnection And Healing after Trauma and Transition (RAHATT). RAHATT is a group of mature aged Arabic speaking refugee women in South West Sydney. Pearl Fernandes and Yvette Aiello are the co facilitators at STARTTS who have initiated this project. The women who belong to RAHATT are directly or indirectly victims of the violence and human rights violation following the conflicts in Iraq and more recently the offensive launched by militants of Islamic State (ISIS) and other Sunni insurgents in Iraq and Syria.

In the beginning, RAHATT performed clinical interventions to assist the women to reflect on their past, feel more settled in the present and find a new perspective for their future. The group then began to share cherished activities that they had engaged in in their homelands. Sharing food, stories and songs from their past and visiting places of worship have developed into a regular routine for RAHATT.
